**ARTICLES OF INCORPORATION**

We, the undersigned, are forming a business corporation under the provisions of the Liberia Code of Laws, revised Volume II, Title Five (5), association law. We are creating this document, signing it, acknowledging it, and submitting it to the office of the Liberia Business Registry's Registrar. In doing so, we certify as follows:

**ARTICLE I: NAME**

The name of the organization (from now on considered a "CORPORATIVE ") shall be known as **JETRO WEB DEVELOPMENT**

**ARTICLE II: PURPOSE/OBJECTIVES**

The purpose and objectives for which this organization is formed shall be to undertake all lawful acts and activities under the Liberia Code of Laws, revised Volume II, Title Five(5), including but not limited to the following:

1. To provide young Liberians with life-changing technological skills
2. To help build the world we live in
3. We want to use people's software to support people's movement.
4. We want to breed the new generation of software developers in Liberia, and Africa by an extension.

**ARTICLE III: DURATION**

The organization shall have perpetual existence and all necessary powers that an organization under the Liberian Business Corporation Act may have.

**ARTICLE VI: BOARD OF DIRECTORS**

The number of Board of Director members, who are subject to the provisions of these Articles of Incorporation, shall hold office until their successors are duly qualified and elected; shall not be less than seven (7).

**ARTICLE VII: PRINCIPAL ADDRESS AND REGISTERED AGENTS**

The principal office shall be at 24<sup>th</sup> Street Sinkor, Tubman Boulevard, Montserrado County, Liberia, West Africa. The name and address of the registered agent is Mr. Spencer Cooper, who resides at 24<sup>th</sup> Street Sinkor, Tubman Boulevard, Liberia.

**ARTICLE VIII: INCORPORATORS**

The Organization reserves the right to amend, alter, change, or repeal any provisions contained in this certificate of incorporation in the manner now or hereafter prescribed by the Liberian Corporation Laws and rights conferred upon the Board of Directors herein granted subject to this reservation.

**ARTICLE XII: CORPORATE SHAREHOLDING RATIO**

The ownership ratio of the corporation shall be as herein stated or as jointly directed by the corporation owners.

**ARTICLE XIII: CORPORATE COMMENCEMENT**

The Organization’s existence shall begin upon filing these articles of incorporation with the Liberia Business Registry as of the date stated in these articles.
